



CKK BUCKS PROGRAM AGREEMENT

**WITNESSETH:** KBPA FOUNDATION, a Hawaii nonprofit corporation, agrees to allow Vendor to participate in the CKK Bucks Program associated with the Event on November 7, 2009 and to publicize Vendor as a CKK Buck Participating Merchant.

Event: Celebrate Kaimuki Kanikapila Craft Fair & Street Festival  
Event Date & Hours: Saturday, November 7, 2009 (9:00 a.m. to 3:00 p.m.)  
Program End Date: Saturday, November 14, 2009  
Merchant Redemption Deadline: Friday, November 13, 2009

**IN CONSIDERATION, VENDOR AGREES TO:**

- a. Ensure that it and all its workers are:
  - (i) Fully aware of the CKK BUCKS promotion,
  - (ii) Instructed to be courteous to patrons presenting a CKK Buck to Vendor,
  - (iii) Instructed as to what a valid, authorized CKK Buck looks like<sup>1</sup>,
  - (iv) Inform patron that "no change is given" if purchase is under \$5.00.
- b. Accept and honor any CKK Buck (*validated with the proper authorization embossment seal*) which is presented to Vendor or its employee for \$5.00 in goods, merchandise or services during event hours (9:00 a.m. to 3:00 p.m.) on Saturday, November 7, 2009. Vendor will not impose any restrictions on use.
- c. Ensure that only CKK Bucks with the proper authorization embossment seal and ink stamp are accepted.<sup>1</sup>
- d. Post in a predominant spot on or near its entrance door or booth the flyer identifying Vendor as a CKK Buck Participating Merchant.

<sup>1</sup> An official example specimen shall be provided.

- (i) Vendor who has store frontage shall continuously post the flyer from Saturday, October 31, 2009, through Saturday, November 7, 2009.
- (ii) Vendor who only has a booth will post the flyer during the event hours.
- e. Monitor the CKK Buck Program at all times and immediately contact Daniel Yokoo at the KBPA Information Booth if any discrepancies or disputes in the redemption of a CKK Buck arises.
- f. Allow KBPA Foundation, Kaimuki Business & Professional Association (“KBPA”), to publish Vendor’s name as participating in the CKK Bucks program.
- g. Understands and agrees that each valid CKK Buck must be presented to either (i) the CKK Buck Redemption Location, or (ii) the Treasurer of the KBPA Foundation for redemption no later than 5:00 p.m. on Friday, November 13, 2009 and that Vendor will be reimbursed \$4.00 for each valid CKK Buck. Crafters may redeem CKK Bucks on Event day.
- h. Understands that no reimbursement will be made for a lost/damaged CKK Buck or CKK Buck presented for redemption after the Merchant Redemption Deadline.
- i. Upon reasonable notice, obey any additional rules which may be implemented for the safety of the public or the efficient administration of the CKK Bucks Program.
- j. Fully understands that KBPA Foundation, KBPA, the CKK Buck Redemption Location, and their agents and employees shall not be liable for any claim, damage or loss arising or relating to the CKK Buck program.
